

TERMS AND CONDITIONS

Unless otherwise expressly agreed, it is understood and agreed that the following terms and conditions shall apply.

- 1) Al Baraka Islamic Bank (B.S.C.) (C.) ("the Bank") has the right to advise / confirm the letter of credit through its correspondent / Agent Banks without recourse to the applicant.
- 2) The Bank may at its option call for presentation of drafts drawn on the confirming bank, or on itself, or it may waive presentation of drafts.
- 3) All instructions in connection with this credit are transmitted entirely at the applicant's risk.
- 4) Neither the Bank nor its correspondent / Agent Banks shall be in any way responsible for the correctness of the description, quantity, quality or value of the merchandise represented in the documents, for the amount of shipper's charges, for loss or damage to the goods, or the terms, conditions or sufficiency of insurance documents.
- 5) The applicant undertakes to insure the shipment in favour of the Bank and present copy of such insurance certificate prior to the shipment to the Bank if the Credit is not subject to CIF or CIP terms.
- 6) After the expiry of any insurance cover in connection with this credit, the applicant will arrange further cover or the Bank is authorised, at its option, to arrange such cover at the applicant's expense.
- 7) Any sums received in respect of claims under any insurance cover in connection with this credit shall be held at the Bank's disposal.
- 8) In default of due payment the Bank is authorised to dispose of the merchandise consigned in any way that it may deem fit to cover the amount due.
- 9) The applicant certifies that to the best of his knowledge, the beneficiaries of the credit have no connection with Israel, and the terms of this credit in no way contravene the regulations issued by the Israel Boycott Office, and the applicant agrees to indemnify the Bank against any loss incurred as a result of their opening this credit on behalf of the applicant.
- 10) The applicant agrees and undertakes that all drawings under this credit will be paid by him at the Bank's selling rate ruling on the date on which the Bank purchased the currency of the drawing in order to cover the amount drawn.
- 11) This credit is subject to the current applicable Uniform Customs and Practice for Documentary Credits Revision International Chamber of Commerce Publication.
- 12) The Bank is authorised to debit any cash collateral it may require and all charges under this Letter of Credit to the applicant's account.
- 13) The Bank has the right to advise this Letter of Credit by any authenticated tele transmission ways.
- 14) The applicant undertakes to provide copy of Proforma Invoice / Purchase Order or any prior agreement with the supplier to the Bank before issuing the letter of credit.
- 15) The Bank has the right to request for authenticated/attested documents by any Arab Embassy/Consulate and or Chamber of Commerce.
